Re: Westtown Township Board of Supervisors Conditional Use Application of Toll PA XVIII, L.P. Virtual Hearing via Zoom on August 31, 2020

Dear Counsel and all Unrepresented Parties:

Please allow this correspondence to confirm the status of the hearings for the above-referenced conditional use application. A virtual hearing was scheduled to be heard via the Zoom electronic format on August 5, 2020 at 7 PM, but was subsequently cancelled upon the concurrence of Toll and the Township given the widespread power outages and storm damage from Hurricane Isaias. The rescheduled virtual conditional use hearing will now occur on Monday August 31, 2020 beginning at 7 PM. Accordingly, enclosed please find the notice of the hearing for August 31 at 7 PM via the Zoom platform. The enclosed notice contains important information needed to login to Zoom on the night of the hearing to ensure your participation.

Toll has confirmed that it intends to present its traffic witness on the evening of August 31 and no other witnesses. It is anticipated that the traffic discussion may last over the course of several meetings, but that is unknown at this time. The hearing on August 31 is anticipated to conclude at approximately 9 PM barring any technical difficulties at the outset, with a break for the court reporter around 8 PM. Toll has committed to producing their traffic witness at the next hearing, currently scheduled for Monday September 14, 2020 at 7 PM, regardless of whether or not such testimony concludes on August 31. Thus, please come prepared to ask any questions you may have of Toll's traffic witness on both August 31 and September 14. The exhibits related to Toll's traffic witness have been marked as A-42 through A-59 and are available on the Township's website for your review prior to the hearings.

Also enclosed is a detailed explanation on registering for and utilizing Zoom in preparation for the hearing. I strongly encourage you not to wait until the evening of the hearing to review the Zoom instructions. It is anticipated that the Zoom hearing process will take longer to conduct than an in-person hearing given the constraints of the virtual format. The virtual platform often has a slight delay when speaking such that the parties and the witnesses need to wait a brief moment before responding to a question or before asking a question so that more than one person is not speaking at a time. As this is an on-the-record proceeding, the Court Reporter will be participating and transcribing the hearing as usual. The Zoom hearing audio and video will be recorded in order to assist the Court Reporter in transcribing the testimony. Following the completion of the hearing transcript, the Zoom recording will be destroyed.

When registering for the Zoom hearing, please ensure that you enter your full name so that we can recognize all parties correctly. As with the in-person hearing, the parties will be recognized individually and given the opportunity to cross-examine the witnesses. As the exhibits are referenced during the hearing, Toll and the Township will have the ability to display each exhibit on the screen for all parties and the public to view in real time. The non-party members of the public will have the opportunity to observe the hearing as they would if the hearing were in-person, but public comment is deferred until the end of the evidentiary portion of the hearing as it was in the Crebilly I proceedings.

When the hearing commences, the Board and Toll will be unmuted and the video will be activated so that all parties and the public may see the proceedings. All other parties will begin the proceeding muted and without video activated. As each other party is recognized, they will be unmuted and their video will be activated so that the Board, Toll and the witness, as well as all others, may see the person speaking. I request that you please plan to utilize a computer or other device equipped with video and audio capability and that you test the audio/video capabilities in advance of the hearing. Please try to find a quiet location in which to conduct the hearing so that all parties may clearly hear the proceedings and meaningfully participate. Kindly also provide a copy of this letter and the within instructions to any witnesses you intend to produce during the hearing so they are properly informed of the process.

THE WESTTOWN TOWNSHIP BOARD OF SUPERVISORS will meet virtually via the Zoom Platform on Monday, August 31, 2020, at 7:00 pm., prevailing time, to hear the following:

THE CONDITIONAL USE APPLICATION OF TOLL PA XVIII, L.P. The property is more commonly referred to as "Crebilly Farm" and consists of the following UPI Nos.: 67-4-29, 67-4-29.1, 67-4-29.2, 67-4-29.3, 67-29.4, 67-4-30, 67-4-31, 67-4-32, 67-4-33, 67-4-33.1 and 67-4-134. The parcels total approximately 322.36 acres of land and are bounded by Wilmington Pike (S.R. 202/S.R. 322) in Westtown Township to the east, West Pleasant Grove Road to the north, South New Street to the west, and Street Road (S.R. 926) to the south. The parcels are owned by Crebilly Farm Family Associates, L.P., David M. Robinson, Laurie S. Robinson and David G. Robinson, and the Applicant is the equitable owner. The parcels are located in the A/C – Agricultural/Cluster Residential and R-1 Residential Districts of the Township. The parcels are currently used for agricultural and residential uses. The Applicant seeks conditional use approval pursuant to §170-900 et seq. of the Zoning Ordinance to permit a flexible development proposing a total of 319 residential units, consisting of two existing homes, 182 single-family detached dwellings and 135 townhomes, and also containing internal streets, utilities, stormwater management facilities, landscaping, community recreation facilities, and other improvements, and any other such relief deemed necessary by the Board of Supervisors.

To minimize public exposure to COVID-19 and maintain social distancing, this meeting will be conducted via Zoom, an online video conferencing service.






