This letter will serve as confirmation that the above referenced property is situated within Aqua Pennsylvania Inc.'s ("Aqua") service territory. Service will be provided in accordance with Aqua's Rules and Regulations.

This proposed subdivision will require a main extension for service to all the proposed lots. Based on the proposed plan, Aqua will require main extensions from Aqua's existing 12-inch main in W. Pleasant Grove Road at both entrances to the development. In addition, Aqua will require that the development tie-into Aqua's 12-inch main in W. Street Road at the development's entrance there. Main extension plans must be prepared and submitted to this office for review and approval. Following approval of the main extension design and plans, construction of the main extension project would be completed by the Builder under our standard Builder's Extension Agreement.
