THE CONDITIONAL USE APPLICATION OF WESTTOWN SCHOOL. The property is located at 975 Westtown Road, and is comprised of the following parcels: UPI Nos. 67-2-19, 67-2-24, 67-2-24.2, 67-2-25, 67-2-25.1, 67-2-25.2, 67-2-25.3 and 67-5-27. The parcels total approximately 579.61 acres owned by the School, which is located in the A/C Agricultural/Cluster Residential District of the Township. The Applicant seeks conditional use approval pursuant to §170-1514.D(5) (Permanent recreational and sports lighting and nighttime events) and §170-2009 (Conditional Uses) of the Westtown Township Zoning Ordinance to permit improvements to the athletic fields including permanent exterior lighting for athletic events on the existing turf athletic fields located on UPI No. 67-5-27 (195 acres), and any other such relief deemed necessary by the Board of Supervisors.
