



## Annual Recreational & Sports Nighttime Events Permit Application

Applications shall be made on annual basis and 45 days before each event or the first event in a series of events. It is applicant's responsibility to notify the Township of any changes, additions to the event schedule. All permanent field lighting events shall comply with the following criteria:

- Such events are limited to 30 per year (3 additional allowed for playoff events).
- Must be directly related to the school where applicable athletic fields are located.
- Must be extinguished by 10:00 pm, unless specific permission is received by the Township. Except that such permission will not be granted more than four times per year.
- Must comply with Section 170-1514.D.(5) Permanent recreational and sports lighting and nighttime events, and subject to conditions of Conditional Use approval.
